SOUTH CAROLINA DHEC FEES

\$.79 Charge per water customer.

SPRINKLER HEAD FEE OUTSIDE TOWN

All businesses located outside the corporate limits of the Town having a sprinkler system tap-on to the Town's water system shall pay an annual charge to the Town of \$2.97 for each sprinkler head, forming a part of said sprinkler system, to be billed and paid monthly.

SCHEDULE OF OTHER WATERWORKS AND SEWER SERVICE FEES

SERVICE CONNECTION FEE

\$75.00 Service fee charge for connection of water and sewer.

SERVICE CONNECTION DEPOSIT

\$30.00 Deposit for connection of water and sewer for all customers with a letter of credit (12-month credit history), with no more than two (2) times past due from any other utility company.

\$75.00 Deposit for connection of water and sewer for all customers without an acceptable letter of credit from other utility company.

\$100.00 Deposit required prior to reconnection of any customer who has not previously paid a deposit and who has been disconnected four times within a preceding twelve (12) month period for failure to pay water and/or sewer charges in timely manner. A disconnect-reconnect administrative fee will also apply.

Deposits will be applied to the customer's account after the account has been in good standing after twelve (12) consecutive months.

Deposits held on customer accounts at the time of the enactment of this ordinance shall be applied to the customer's account at such time as the account has been in good standing for twelve (12) consecutive months.

DISCONNECT-RECONNECT ADMINISTRATIVE FEE

\$30.00 Charge for water disconnection-reconnection

\$50.00 Additional charge when water is reactivated by the customer or any other parties before past due bill and the disconnect-reconnect administrative fee has been paid.

This fee shall be applied at 9:00 AM on the day the water is scheduled to be disconnected for nonpayment of bill regardless of whether the delinquent bill is paid prior to actual disconnection.

CUSTOMER TRANSFER FEE

\$25.00 Charge for customers transferring their account from one service address to another provided the account for the original service address is paid in full.

RAW SEWAGE DUMP FEE

\$75 Charge for direct dump into waste treatment facility

COURTESY CONNECTION

\$25 Charge for water connection for a period not to exceed two (2) days

FIRE SERVICE CONNECTION FEE – Commercial Only

SPECIAL RATES

Town Council may negotiate special water and/or sewer rates for any customer classification that makes a significant capital contribution to the System.

METERED WATER RATES FOR SIGNIFICANT WATER USERS

Any significant water user shall be entitled to the lower water rate set forth in the Schedule of Water and Sewer Fees. A Significant Water user is any user connected to the Town’s water system that uses more than 500,000 gallons for more per month.

SEWER RATE ADJUSTMENT FOR INDUSTRIAL USERS

In the event that an in-town industrial user that is discharging waste water into the public sewer system produces evidence to the Town that more than twenty five (25%) percent of the total volume of water used for all purposes does not reach the public sewer system, then an estimated percentage of total water consumption to be used in determining industrial sewer fees may be approved by the Town Council.

EXCESS TREATMENT SURCHARGES

The “mg/l” (concentration) is converted to “lbs/day” by calculating the industries reported 24 hours composite flow rate multiplied by the number of days discharging in the quarterly period. The mass (lbs/day) is then multiplied by the current surcharge rate and the number of days of discharge.

SCHEDULE OF SANITATION FEES

Sanitation service charge for Residential Users shall be as follows:

\$16.00 Sanitation Fee

Extra Capacity Roll-out Container. One additional roll-out container is allowed per residence for a \$100.00 one-time fee. The Sanitation Fee will be charged for the extra capacity roll-out container.

Sanitation service charge for Non-Residential users shall be as follows:

\$25.00 for up to two (2) roll-out containers

PLUS \$25 for each additional roll-out container
