

BUSINESS LICENSE RENEWAL

All Town of Clover 2012-2013 Business Licenses expire on June 30, 2013.

According to the Business License Ordinance, license renewal fees must be paid for each business subject to the applicable rate classification on or before July 31, 2013.

Failure to renew will result in a 5% penalty for each month you are delinquent.

In-Town Businesses Only: When renewing your business license, you **MUST** bring in a copy of your tax return for verification of gross receipts. If you have not had your taxes completed, please bring a letter from your CPA confirming your gross receipts. A business license may not be issued without verification.

All contractors will also need to present a copy of their South Carolina State Contractors License.

Renewal applications will be mailed in June to make the application process more convenient. Please contact Town Hall at 222-9495 with any questions concerning your business license renewal fee. Also, visit www.cloversc.org for more information.

CLOVER FAÇADE GRANTS

The Town of Clover is offering assistance to commercial property owners to repair and improve the exteriors of their buildings. Up to five \$1,000 competitive grants are expected to be awarded through the Façade Grant Program.

Qualifying projects are eligible for a grant of up to \$1,000 per exterior on a 50/50 matching basis with a minimum investment of \$300 per property. Improvements must be consistent with and visibly improve the original or historic character of the building. Suggested improvements include painting, signage, awnings, doors, windows, lighting, and restoring the original materials and finish.
