LATE NOTICES

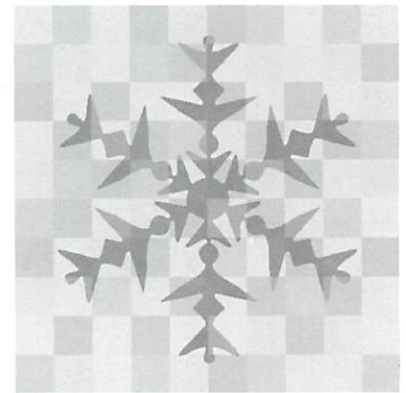
Effective January 1, 2014, the **Town of Clover will no longer be sending late notices** to customers who have failed to pay their water/sewer bill by the due date. Water bills are due by the 15th of each month. A 10% late fee will be applied after the 15th. Failure to make a payment agreement by the 20th or failure to pay by 9AM on the 21st of each month will result in a \$30 administrative fee applied to the account even if the water has not physically been turned off.

The billing statement customers receive at the beginning of each month will serve as the only notice of the amount due. Customers have a variety of ways to remit payment including the drop box at Town Hall, on-line bill pay, and bank draft. For more information, call Town Hall at 222-9495 or visit www.cloversc.org.

WINTER WEATHER PREPARATION

Winter is upon us! Here are a few things you can do to make sure you and your home are ready for winter.

- Have your furnace professionally serviced. This includes cleaning and checking the supply lines, furnace ducts, filters and thermostat.
- Check the glass in your windows and doors. If any are cracked or broken, replace to prevent heat loss.
- Add weather stripping around the edges of doors and windows to prevent cold drafts from coming in.
- Trim any **tree** branches that are overhanging your roof or are close to electric or utility wires.
- Turn off the water supply to your outside taps and drain the water supply lines leading to them.

2013 AUDIT REPORT

On December 9, 2013, the Town's independent auditor reported their findings to Town Council on the Town's financial position for the year ended June 30, 2013. The Auditor issued an Unmodified Opinion, the best the Town can receive, regarding the management of the Town's funds, accuracy of the financial statements, and effectiveness of the Town's internal controls. The Auditor reported a healthy reserve for the General Fund and noted that the Town would need to carefully monitor the Water/Sewer Fund as there was an increase in operating expenses but a decrease in revenues for the year.
