WATER PAYMENT AGREEMENTS & CUT OFF FEES

Water payment agreements can not be made on cut off day (21st of the month). If you would like to make a payment arrangement, you must make the agreement before 5PM on the 20th of the month. Contact Town Hall if you have any questions regarding your eligibility to make a payment arrangement.

Failure to pay by 9AM on the 21st of each month or to make a payment agreement as described above will result in a \$30 administrative fee applied to the account even if the water has not physically been turned off.

If water cut off day falls on a Saturday or Sunday, the payment arrangement must be made by the Friday before and the disconnect charge will be applied at 9AM on the Monday after. For February 2015, the payment arrangement due date is Friday the 20th; water cut-off day is Monday the 23rd and payment must be received before 9am on the 23rd.

NEW ZONING ORDINANCE

In December the Town Council adopted a new zoning and land development regulations ordinance. This ordinance includes a number of regulations that will impact citizens, business owners, contractors, and developers. The new ordinance can be found on-line at www.cloversc.org

One new provision in the Ordinance is the creation of two overlay districts: Historic Preservation Overlay and Corridor Overlay. Properties within these districts will be required to meet additional zoning regulations. These overlays will not be effective until April 1, 2015.

The ordinance also now allows micro-farms. Council will consider regulations at its meeting on February 9. The proposal is to allow residential properties zoned R12 to have up to 4 chickens (no roosters). Once approved, the regulations and permit requirements and information on how to determine the property eligibility will be available at Town Hall or www.cloversc.org.

To ensure that your sign, exterior upgrade, parking and landscaping changes, renovation, etc. is allowed, please contact the Town prior to any work.
